

AMENDMENT NO. 11
DENTAL SERVICES CONTRACT BETWEEN
FLORIDA HEALTHY KIDS CORPORATION AND DENTAQUEST OF FLORIDA, INC.

This Amendment No. 11, entered into between the Florida Healthy Kids Corporation ("FHKC") and DentaQuest of Florida, Inc. ("Insurer") (collectively referred to as the "Parties"), amends the Dental Services Contract between FHKC and Insurer ("Contract").

WHEREAS, the Contract allows for amendments by mutual written consent of the Parties;

WHEREAS, the Parties have agreed upon certain revisions to the Contract; and

WHEREAS, the Parties desire to further amend the Contract as provided in this Amendment.

NOW, THEREFORE, in consideration of the mutual promises and agreements herein contained, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Section 3-21 of the Contract is hereby revised by replacing the entirety of the language therein, and substituting as follows:

3-21 Premium Rate

The premium rate charged for the provision of Comprehensive Dental Services for October 1, 2021 through December 31, 2021 shall be as follows:

COUNTY	PER MEMBER PER MONTH
Statewide	\$15.35

2. Except as expressly amended hereby, the Contract shall remain in full force and effect in accordance with its provisions.
3. This Amendment No. 11 sets forth the entire understanding between the Parties with regard to the subject matter hereof. In the event of any conflict between the Contract and this Amendment No. 11, the terms of this Amendment No. 11 shall govern.
4. Except as otherwise expressly set forth herein, this Amendment No. 11 becomes effective upon execution by both Parties.
5. This Amendment No. 11 may be executed in counterparts, each of which shall constitute an original and all of which together shall constitute the same document.
